Due Dates for Housing Fees. The above schedules pertain to the program fees exclusive of housing fees. Housing is normally billed after the designated housing has been accepted by the student. Housing payments are due in full within 20 calendar days of these fees being reflected on the student's statement. IMPORTANT INFORMATION FOR STUDENTS FROM SCHOOLS THAT HAVE A DIRECT BILLING ARRANGEMENT FOR THE PROGRAM IN WHICH YOU ARE PARTICIPATING

If you are from a school that has a **Direct Bill A** arrangement, you are required to only pay the \$400 initial payment. If you are from a school that has a **Direct Bill B** arrangement, you are required to pay the \$400 initial payment and a second payment of \$1500; you will then be required to pay for the remainder of the housing cost within 20 calendar days of these fees being reflected on the student's statement. If you are from a school that has a **Direct Bill C** arrangement, you are required to pay the \$400 initial payment. You may also be required to pay any additional amount to cover the cost of the housing deposit, if applicable, within 20 calendar days of these fees being reflected on your statement.
